On June 6, 2021 a document titled, "Notice of Trespass with Liability, Acceptance of Oath, Notice of Criminal Activity of Officers(s), with Request for Admissions, Notice of Pretrial Discovery Under the Freedom Of Information Act with Intent to Sue", was served to you Kay A. Hickman in your Office tracking #70202450000009413120, this package was delivered on June 15, 2021 at 3:36 pm Oroville, Washington, 98844 and we have yet to receive a response from any of the respondents named in this document; and,

You Kay A Hickman, et alla, are now noticed as sitting in emoluments of your oath of office have a duty to respond thus your silence is a breach of trust and acquiescence; and,

If any man or woman hired as a "Law Enforcement Officer" violates us in any way it will result in immediate orders for prosecution under General Orders No 100: The Lieber Code

Articles. 44.

"109 All wanton violence committed against persons in the invaded country, all destruction of property not commanded by the authorized officer, all robbery, all pillage or sacking, even after taking a place by main force, all rape, wounding, maiming, or killing of such inhabitants, are prohibited under the penalty of death, or such other severe punishment as may seem adequate for the gravity of the offense".
