Obligation of Good-Faith Dealings in General

Under the UCC

Section 1-203 of the UCC provides, "Every contract or duty within this Act imposes an obligation of faith in its performance or enforcement." Good faith is defined at Section 2-103(j) as "honesty in fact and the observance of reasonable commercial standards of fair dealing." This is pretty much the same as what is held by common law, which "imposes a duty of good faith and fair dealing upon the parties in performing and enforcing the contract. Restatement (Second) of Contracts, Section 205.

The UCC's good faith in "performance or enforcement" of the contract is one thing, but what if the terms of the contract itself are unfair? Under Section 2-302(1), the courts may tinker with a contract if they determine that it is particularly unfair. The provision reads as follows: "If the court as a matter of law finds the contract or any clause of the contract to have been unconscionable at the time it was made, the court may refuse to enforce the contract, or it may enforce the remainder of the contract without the unconscionable clause, or it may so limit the application of any unconscionable clause as to avoid any unconscionable result."

"Parties should not lie or knowingly mislead each other about matters related to the performance of the contract". The Contractual Principle of Good Faith and the Duty of Honesty in Bhasin v. Hrynew, 2015 CanLIIDocs 105

"Since 2014, Canadian contract law has recognized that commercial parties owe one another a duty of "honest contractual performance", as an element of the principle of good faith. According to the Supreme Court of Canada in its leading decision" Bhasin v. Hrynew, 2014 SCC 71,




