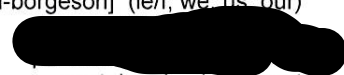



We are writing to request an Administrative Hearing with this Agency with the intention of clearing any and all misunderstandings regarding our being born onto earth and how we experience life; we are seeking an Administrative Hearing to correct the record and we are seeking reciprocity in the form of just compensation as per the invoices served to

Whereas, we reiterate, we wish to find an amicable solution regarding how we are being treated; and what is being forced upon us as an experience and we have included the documents served to the men and women involved in the trespass so as to inform them of the crimes they have committed and which are being perpetrated against us; and,

Whereas you **Marco E. L. Mendicino** are required to read the Notices served to these men and women directly involved in the crimes against us and these Notices are published on our website as a way to reduce waste and abuse and to preserve the earths resources (see Attachment #2) this link along with a " Notice of Criminal Complaint; Criminal Negligence Causing Bodily Harm; Dereliction of Duty With Liability; With Intent To Sue; Freedom of Information Act in preparation for an Administrative Hearing directed to you and is included in this mailing; and which is going out to the "Public Servants" involved in the crimes against mankind and against life; and,

We are dispelling any and all presumptions and assumptions by the men and women working in this and other agencies of us being a "pauper", a "taxpayer" (people subservient to the "Crown" called, "employers" have hired us and trained us and who have tricked us into being a "taxpayer" reporting us as such to the Canada Revenue Agency after they had us complete the "terms of employment" contract); and,

Whereas we are not subject to any "legislation," department", or "agency" created by such "authorities," nor to the "jurisdiction" of any "employees", "officers", or "agents" deriving their "authority" therefrom. Nor do any of the "statutes", "codes", "regulations", "acts of parliament", or "regulations" of such "authorities" apply to us or have any "jurisdiction" over us, we are our own "authority", the author of our reality; and,

Whereas we the people born to earth are not "human capital", we are not "commercial instruments"; on May 31, 2021 we **Claimant(s)/Declarant(s)Libellant(s) #1 and #2** were approached by men in uniform who proceeded to arrest us without probable cause and with a warrant and without evidence of wrong doing; **Claimant(s)/Declarant(s)Libellant(s) #1** was given a "Forged Instrument" made out by Kay A Hickman a woman working as Fines Penalties Forfeiture Officer for US Immigration and Customs Enforcement for Homeland Security demanding payment; she has committed a number of crimes in the creation of this security which has been reported; and,

The government form called, "CBP Form 5955A (01/15) from DHS U.S.Customs and Border Protection" and dated May 31, 2021 indicates that these people working for "Border Protection Agencies" assume that we are a "Commercial Entity" according to the code that **Claimant/Declarant/Libellant #1** was charged with violating [19 USC 1459](#) and having written "business" beside his name (see Attachment #3); as you know a man cannot be a business and the "Agents" can only do business with a business; and,

Be advised that there is no "oath of office" or "contract" on the record of **Claimant/Declarant/Libellant #1** being a "citizen" of United States Of America Corp. On October 7, 2020 **Claimant/Declarant/Libellant #1** was given an invalid form by a man acting as a Port Official for the Corporation called "Canada" (see Attachment #4); and there is no "oath of office" on the record) or contract on the record of **Claimant/Declarant/Libellant #2** being a "citizen" of "Canada"; so how can **Claimant(s)/Declarant(s)Libellant(s)** possibly be an "Individual" as stated in [19 USC 1459](#)?

Neither one of us are an "Individual" as defined in [5 U.S. Code § 552a](#) and as such are not "human capital" as described in [5 CFR § 250.203](#) - Strategic human capital management systems and standards. Strategic human capital management systems, standards, and focus areas are defined within the Human Capital Framework (HCF). The four systems described below provide definitions and standards for human capital planning, implementation, and evaluation. The HCF systems and standards are:

(a) Strategic planning and alignment. A system that ensures agency human capital programs are aligned with agency mission, goals, and objectives through analysis, planning, investment, and measurement. The standards for the strategic planning and alignment system require an agency to ensure their human capital management strategies, plans, and practices - "

Nor are we a homosapian as defined in [1 USC 8](#) defines human as "a member of the species homosapian, which is further defined by it's inventor as "a primate animal"; a truly "primitive animal" and a "humanoid" is an entity that does not have the

wherewithal (the emotional, spiritual, or mental capacity) to create technology in harmony with the natural world thereby deliberately destroying it's environment; and,
