We made mistakes when we served you with the previous notice and is why we have made corrections to this Notice; it is our desire to clear up any and all confusion and is why we are serving you with this Notice of Default Regarding The Lack of Response To The Notice of Criminal Complaint; Criminal Negligence Causing Bodily Harm; Dereliction of Duty With Liability With Corporate-Government Questionnaire Under The Freedom of Information Act in preparation for an Administrative Hearing; and are wondering why we have not yet received the Corporate-Government Employer/Employee Questionnaire that we mailed to you on June 10, 2021; you are required to complete this questionnaire under the Freedom of Information Act; and

We have included a revised copy of the Corporate Government Questionnaire and you are required to send this completed form along with your reports regarding the incidents that took place on May 31, 2021 or any other day between you and **Claimant(s)/Declarant(s)Libellant(s) #1 and #2** and you are required to read the "online" article published on our website and titled, "Law Enforcers Are Supposed To Know "Due Process of Law"! Whereas this Notice of Criminal Complaint; Criminal Negligence Causing Bodily Harm; Dereliction of Duty With Liability and Intent To Sue; is a revelation that the people working as "Law Enforcement" are "Policy Enforcers" for a "Private Members

Organization" known as "The Legal Society"; and of which we **Claimant(s)/Declarant(s)Libellant(s) #1 and #2** are not members; and,

As a result of your lack of oversight, lack of insight, poor training, lack of education of the law you are breaking the laws as they are written and committing horrendous crimes and allowing for horrendous crimes to be committed against innocent people; and,

It is imperative that you realize that we are not the "class of person" that would wilfully participate in the trafficking of man or animals, and will not participate in the sexploitation of our children to this "Private Members Organization", and we will not allow anyone to force us to participate in ritualistic abuse and sacrifice, or murder; and will not sit idle while the clinically insane implement technology to destroy man's genome and attack life on earth to keep mankind in a lower states of consciousness; and,

Hayes, 92 Okla 32, 227 F. 417

The courts are not bound by an officer's interpretation of the law under which he presumes to act. Owen v. Independence, 100 S.C.T. 1398, 445 US 622

"Officers of the court have no immunity, when violating a Constitutional right, from liability. For they are deemed to know the law."

"Equity follows the law." **Equity** does not replace or violate the **law**, but it backs it up and supplements it. Equity follows appropriate rules of law, such as the rules of evidence and pretrial discovery.

At a minimum, the inspiration behind the "rule of law" is a sense of order and hierarchy.

"rule of law": The "rule of law" is a principle of longstanding constitutional value. It is recognized in the preamble of the Constitution Act, 1982, and has been utilized by the courts as important constitutional rhetoric, and also as a doctrine that produced juridical effects in various contexts.
